### EASY LIVELIHOOD Terms and Conditions:

1. New EL members must fill out an application form and submit this to the Easy Pha-Max office.
2. Once an application is approved, the EL member is now entitled to participate in the EL Program.
3. An Identification Card (ID) will be issued to every new member. The EL member must present this ID when conducting transactions with the Easy Pha-Max office.
4. Each EL member must be introduced by a GBHE or by another EL member. EL members will then serve as sub-distributors of their introducer. All purchases made by the EL member will come from the e-wallet of their introducer. All EL members are prohibited to buy from any other Easy Pha-Max GBHE except from their introducer. GBHE's are not allowed to sell products to EL members they did not introduce. Violation will result in termination of the membership of the EL member and of the benefits of the GBHE from the repurchase program.
5. A minimum initial purchase of \$200.00 is required to avail of the lifestyle discount. To upgrade to the momentum, business, or career pack, EL members can accumulate the required product purchase within a calendar month. The introducer is responsible for monitoring the accumulation of sales and release of additional free products corresponding to the upgrade.
6. To upgrade to a GBHE, EL members must pay the prevailing GBHE Business Rights Fee.\*
7. The company reserves the right to change any provision(s) with out prior notice.

*\*An EL member who chooses to upgrade to a GBHE can use the volume accumulated in the same month when the upgrade is being done. They will then have to pay the difference between the prevailing GBHE Business Rights Fee and the volume they have accumulated that month. GBHE upgrades are not eligible for enrollment incentives available through the Easy Pha-Max Rewards Program.*
